#### **Acquinton Church Stabilization**

Our historical society is responsible for Acquinton Church and its remaining structure has deteriorated to the point we weren't sure it could be saved. Then along comes Mr. Carroll Lee Walker who has offered to clean up the grounds and stabilize the church – at no cost to us!

The overgrown vegetation has been cleared and a plan is in place to build supporting structures to stabilize the walls and to build a roof. We are working with our attorney, Randy Cook, to transfer ownership of the property to Carroll Lee for one year, for which, he would pay the KWHS the appraised value of \$40,000 (\$26,000 cash and a contribution receipt for \$14,000 for work already completed).

After the completion of the stabilization work, the KWHS will purchase Acquinton Church back for the \$26,000 cash, plus another contribution credit for the appraised value upon completion. Mr. Walker intends to make an additional \$10,000 contribution to the KWHS for the express purpose of upkeep and maintenance of the site. We anticipate completion by end of year. More detail will be shared at our April members meeting.

# Save the County Jail

In October a subcommittee was formed to assess the feasibility of restoring the Old County Jail on the courthouse grounds. Herb White, Danny Wright, Darrell Kellum and a restoration contractor have met to assess the work necessary to save and to resurrect this building. Their initial consensus was that the building is indeed worth the work to save it, and that this work should be completed in two phases. The first phase should be the repair of the roof, and they found that many of the roof slates that have fallen could still be used. The second phase should be restoration of the interior. Darrell is to provide Herb with budget figures. There may be some county funds that could be made available to help in this effort. Herb and Danny are working on that prospect, and we will know more in a few weeks.

#### **Museum Status**

In the past year, our Museum only missed four days out of 103 in operation due to inclement weather and/or lack of staff. This was an extraordinary effort from our volunteers, serving 839 hours to maintain the operation of the museum and special events. We recorded 633 visitors and collected \$728 in donations during that time period.

In November 2008, the Council made a decision to close during December, January, and February. Regular operation hours will be 1:00-5:00 on weekends and visits by appointment with the reopening in March 2009.

A committee started work on a new exhibit entitled "Evolution of Community" with an emphasis on agriculture, trade, businesses and occupations and access to products and services. Students from the National Honor Society at King William High School participated in training as docents for community service hours.
