
From our President

April Meeting Highlights

New Dues Structure for 2009 Approved – A trend analysis of the society's future income and planned spending was presented. Our 2009 expenses will be higher than the past because of the Acquinton Church restoration and the expansion of our computer capabilities. Future annual spending and income should match at about \$2500 (+major project costs.)



In addition to the change in dues, the board suggested additional income should come from fundraisers and creation of annual Society Donor Levels.

New By-Laws Approved – The board had distributed the new by-laws to society members before the meeting. There were no questions or concerns expressed during the discussion period. The by-laws were approved with a unanimous vote.

New Website Demonstrated - The new King William Historical Society Website was demonstrated at our meeting. Several members, with their knowledge of our county and a commitment of significant time, pulled together the pictures and information that best represents the history of King William County. The topics are too numerous to even list in this newsletter. We plan to continue adding 19th century photocopies of citizens of the county, also letters and portraits, so please let us know if you have something interesting.

This is a must see for all our members and students – go to <u>www.kingwilliamhistory.com</u>. If you don't have a computer, find a friend or relative who can access it for you.



Acquinton Church Stabilization

Koelzer and Associates, the engineers employed by Mr. Walker, have completed the structural drawings of the church. All supporting structures will be erected within the interior of the church. We now await the removal of the overhead power lines, which will be rerouted underground in front of the church so that the construction phase may begin. The brick will be filled in with period brick, and the walls will be tied together for stabilization.

Save the County Jail

In October a subcommittee was formed to assess the feasibility of restoring the Old County Jail on the courthouse grounds. Herb White, Danny Wright, Darrell Kellum and a restoration contractor have met to assess the work necessary to save and to resurrect this building. Their initial consensus was that the building is indeed worth saving, and that this work should be completed in two phases. The first phase should be to replace rafters and roofing and the second phase should be restoration of the interior. Darrell has provided us with an estimate and we are in the process of obtaining additional ones. We expect these repairs to be in the range of \$30,000 to \$50,000 and are seeking funding for this project. For more information, contact Herb White. Spring Fest 2009

Documenting King William Cemeteries

Reminder: As mentioned in February's newsletter, we have set June 2009 as the deadline for gathering additional information on old King William County Cemeteries. A new book will be published and made available for a nominal fee. We also hope to make this information available on our new website for online viewing.

Aylett Cemetery

The Aylett cemetery is looking pretty good these days. Grass has been cut, sticks removed, and the periwinkle is starting to recover the inside perimeter of the cemetery. We are asking members to please stop by the cemetery and take a minute to transplant a few pieces of periwinkle from the perimeter walls to the interior. If bits of it are planted throughout, the visual effect will be enhanced and the periwinkle will keep down the weeds. Feel free to visit, as the owners of the property, Sandra and Bill Berry, encourage our help in doing what we can to keep the cemetery looking respectable...helps them too.

Mr. Jarvis Taylor, who spearheaded the project to reclaim this important graveyard from nature, has recently presented the Historical Society and Museum his complete manuscript detailing the history, inhabitants, and reclamation of the graveyard. As this was a dedicated KWHS project, for which funding was solicited and received, we will continue to maintain it. And yes, it would please us to witness a living, breathing Aylett descendent contributing a can of Roundup or its equivalent now and again. Thank you, Jarvis Taylor, for your tireless gift to the county and for the manuscript. And thank you too, Steve Colvin, Wortley White, and Rebecca Townsend for your help with this project.

Map Project

Mr. Bibb Edwards has created an enhanced map of King William County showing historic homes and old home sites, reservations, churches and mills. He has formulated the map from our Wendenburg/ Garber map, along with information from the Gilmer Map, Dr. Harris' books, and other sources. Bibb will allow us to add more information to create a more comprehensive historical account of the county. From here we will ask those who live in various sections of the county to present more information from their neighborhoods relating to old home sites and graveyards so they may be placed on the map. We want all the old schools and additional church locations documented as well. We will present this map at our October meeting. If you have information on old home site foundations, old wills or deeds detailing family graveyards, please let Lloyd, Bibb, or Steve Colvin know about them.

King William Historical Museum


